AGREEMENT ON COOPERATION

Kyiv / Cambridge/London UK

25 March 2020

Public Institution «Institute of Environmental Economics and Sustainable Development of the National Academy of Sciences of Ukraine» (referred to as the Institute) represented by its Director, Academician of the National Academy of Agrarian Sciences of Ukraine, Doctor of Economic Sciences, Professor of Economics Khvesyk Mykhailo Artemovych, acting on the basis of the Statute of the Institute, from one side, and Royal Society Industry Fellow Dr Sivasambu Bohm, PhD, Chart. Chem. FRSC, FTSC represented by Graphene & Nano Materials Expert, acting on the basis of Imperial College London, Department of Chemistry, White City Campus, the other part (called "The Parties"), have entered into this Agreement regarding the following.

1. SUBJECT OF THE AGREEMENT

- 1. The Parties cooperate on the basis of this Agreement in the following areas:
- 1.1. Joint implementation of scientific and research projects on the problems of economic, social and ecological development.
- 1.2. Holding, with the participation of the Parties, scientific and practical conferences, seminars, symposia, «round tables», as well as joint development of scientifically grounded approaches to solving economic, social and ecological problems.
- 1.3. Formation of joint groups of authors for the preparation and publication of scientific, methodological and educational publications.
- 1.4. Joint expertise of research works, projects, review of scientific, methodological and educational publications.
 - 1.5. Training, retraining and professional development of personnel.
- 1.6. Participation of the representatives of the Parties in lectures, courses and workshops according to the profile of the Parties.
- 1.7. Exchange of scientific and technical information representing mutual interest.

1.8. Formation and development of joint scientific and information systems.

2. IMPLEMENTION OF THE AGREEMENT

- 2.1. The rights and obligations of the Parties for each specific program of cooperation, the procedure of fulfillment of paragraphs 1.1 to 1.8, as well as organizational and financial obligations, shall be determined on the basis of separate agreements between the Parties.
- 2.2. All disputes between the Parties are resolved through constructive discussions.
- 2.3. The Parties use personal data in accordance with the legislation of Ukraine.

3. VALIDITY OF THE AGREEMENT

- 3.1 This Agreement is operative as from the day of its singing by both parties and will be valid for three years.
- 3.2. The Agreement can be terminated on the initiative of one of the Parties after written notice to the other Party.
- 3.3. If, before the expiration of the above period of time, neither Party notifies in writing of its desire to terminate this Agreement, the Agreement is automatically extended for three years.
- 3.4 This Contract is made out in Ukrainian in two copies, valid equally for both Parties.
